General

Thank you for your interest in the website of attocube systems AG ("attocube"). attocube knows that the careful handling of your personal data and the associated protection of your privacy are very important to you. Therefore, attocube appreciates your trust in us to handle this information conscientiously. attocube takes data protection seriously and observes the relevant data protection legislation such as the EU's General Data Protection Regulation (GDPR), the German Data Protection Act (BDSG) and the German Telemedia Act (TMG). The aforementioned legislation ensure a high level of data protection and in this sense your personal data will be treated confidentially.

We want you to know about the information we collect online, why we collect it and how we process it. We have implemented technical and organizational measures to ensure that data protection regulations are observed both by us and external service providers.

Information on data collection and use

With regard to the existing data protection regulations, attocube is the operator of this website and is responsible for the processing of your personal data in accordance with the relevant regulations of the GDPR. attocube collects data on the basis of the information you provide to us. attocube regularly needs such data for the performance of its business operations, namely the manufacture, marketing and sale of drive and measurement technology for nanotechnology. Any personal data collected, for example, in connection with visits to trade fairs or business contacts, including emails, or through email addresses entered on the website, in the contact form or in relation to newsletters (e.g. name and postal or email address) is provided on a voluntary basis. Such data is processed pursuant to Art. 6(1) b GDPR to facilitate the performance of a contract, to enable us to take steps prior to entering into a contract or, to the extent permissible and desirable (assuming that consent has been given pursuant to Art. 6(1) a GDPR), for our own marketing purposes; without your express consent, we will not disclose them to anyone else other than for the aforementioned purposes.

We will only store your data for the period and the duration of the pre-contractual steps and/or the business relationship or, irrespective of this, for as long as you require information on our products. The data which is stored about you (usually your name, address and email address) will be erased as soon as the purpose for which it has been stored no longer applies and provided its erasure does not conflict with any statutory tax, archiving or other obligations. If such legal obligations exist, the data will be erased after the retention periods have expired.

attocube would like to point out that data transmission over the Internet (e.g. when communicating by e-mail), and especially unencrypted transmissions, may bear security risks. Complete protection against access by third parties cannot be guaranteed.

Information, rectification, erasure, restriction of processing, data portability and withdrawal of consent

You have the right to request information regarding personal data stored by us about you at any time and at no cost, in particular about the origin and recipients of your data as well as the purpose for which it has been processed. This includes the right to demand the rectification, erasure, restriction of processing and portability of such data to the extent permitted by law. If you have given us your consent to collect and store data about you, you have the right to withdraw your consent to the stor-

Data collection and use

Some data is automatically collected by our IT systems when you visit the website. This includes primarily technical data (such as your browser, operating system or page views). Such data is automatically recorded whenever you access our website. We collect the data partly to ensure the proper functionality of the website. Analytics and third-party tools

processing your inquiry). Any statutory provisions, for example regarding retention, shall remain unaffected.

Cookies

We use cookies on our website. Cookies do not harm your computer and they do not contain any viruses. Cookies help make our website more user-friendly, efficient and secure. Cookies are small text files which are placed on your computer and stored in your browser.

Most of the cookies that we use are so-called "session cookies", which are automatically deleted at the end of the browser session. Other cookies remain stored on your device until you delete them explicitly; they enable us to recognize your browser the next time you visit the attocube website.

You can change your browser settings, so that you are informed about the use of cookies and can decide on a case-by-case basis whether to accept or reject a cookie. Alternatively, your browser can be configured to automatically accept cookies if certain conditions apply or to always reject them, or to automatically delete cookies when you close the application. Note: If you disable cookies, you may not be able to use the full functionality of this website.

Cookies which are necessary to allow electronic communications are stored pursuant to Art. 6(1) f GDPR. The website operator has a legitimate interest in the storage of cookies to ensure that the best possible service is provided free of technical errors.

Server log files / data collection when visiting our website

The website provider automatically collects and stores information that your browser automatically transmits to us in so-called server log files. This information could be, for example, the browser type and version, your operating system, the referrer URL, the host name of the accessing computer and the time of the server request.

These data cannot be associated with a specific person and will not be combined with other data sources. attocube reserves the right to check these data at a later time if there are specific grounds for assuming that they have been used illegally. The legal basis for data processing is Art. 6(1) b GDPR, which permits the processing of data for the purpose of performing a contract or in order to take steps prior to entering into a contract.

Statistical evaluation of visits to this webiste - webtracker

We collect, process and store the following data when you access this website or individual files on the website: IP address, website from which the file was accessed, name of the file, date and time of access, amount of data transferred and report on the success of the access (socalled web log). We use this access data exclusively in non-personalised form for the continuous improvement of our Internet offer and for statistical purposes. We also use the following web trackers to evaluate visits to this website:

Matomo

Our website contains tracking code from Matomo (formerly Piwik), an open source web analysis tool (https://matomo.org/) for statistical analysis of visitor access. The web tracking is done by us alone without any personal reference. No data is transferred to third parties. We host Matomo ourselves. We collect, process and store only usage data about the use of our site, such as referrer links, the time spent on certain URLs, the clickstream and also data about your browser settings, such as the manufacturer of the browser and also its version, the screen resolution and the operating system used.

We may also collect and store parts of your IP address and information about the loading speed of our website. From this data we can only create anonymous user profiles and extract statistical information. We also use cookies within the framework of Matomo web tracking to distinguish recurring visitors to the site from first-time visitors. The data collected in this context will not be merged with other personal data that we may have without your separate consent.

Google AdWords and Google Conversion Tracking

Any other data is not collected or only on a voluntary basis. This website uses Act-On to send newsletters. The provider is Act-On Software, Inc. 121 SW Morrison Street, Suite 1600, Portland, Oregon 97204 U.S.A. Act-On is a service with which the sending of newsletters can be organized and analyzed. The data entered by you for the purpose of receiving the newsletter (e.g. email address) is generally stored on Act-On's servers in the European Economic Area. We have concluded a contract with Act-On in which Act-On is obliged to protect the data of our customers and not to pass them on to third parties without authorisation. In individual cases, data processing operations may take place in the USA. If any data transfer to the USA takes place at all, it is carried out in accordance with the relevant regulations of the GDPR and the conclusion of EU standard contract clauses, order processing and appropriate data protection guarantees.

Act-On also allows us to divide the newsletter recipients into different categories (e.g. place of residence). In this way, the newsletters can be better adapted to the respective target groups.
